The aim of this course is *to understand religious diversity* in Indonesian contexts and to some extents international context. The way we learn about religious diversity is through studying the history and beliefs, rituals, and communities of those religions/ beliefs. Besides on the world religions, we pay our attention to the indigenous/ local religion. Since there is a question from the students about inter-religious marriage, then we also will discuss it in Indonesia context. Part of our discussions will be on freedom of religion and last but not least religious conflicts and peacebuilding via Ambon case study. Here, analysis toward international religious revivalism in the 21st century and management of religious diversity are an indispensable course materials.

Requirements and Classroom Etiquette:
