2. Subject Description

The scope of the Law and State Politics subject deals with the transition of democracy in the reform era marked by the fall of the Soeharto government, followed by the amendment of the 1945 Constitution, the establishment of new state institutions and post-reform state commissions. In addition, it is also discussed about legal politics as a new perspective in the study of jurisprudence, which discusses various political configurations and character of legal products. Law and politics also studies the background of establishing state commissions, positions, duties and authorities of the state commission. The most interesting post-constitutional reform phenomenon which studied in this subject is the emergence of the Constitutional Court with the authority attached to them namely the judicial review of the Constitution, the election dispute settlement, the disputes of state institutions, the dissolution of political parties and the impeachment of the president and / or vice president. The final section of this course will examine the various regulatory arrangements and practices in Indonesia.
